The role

We wish to appoint a specialist in AI ethics. Appointees will be flexible, able, and willing to be wide-ranging in their teaching and in their professional development. Preference may be given to candidates with active interests in the relationship of Philosophy & Artificial Intelligence to one or more of the following areas: software and/or technology; employment contexts; diversity and inclusion. Preference may also be given to candidates with interests in sustainability and/or mental health.

Core duties will include teaching across a range of relevant areas, as well as wider educational and administrative duties. Appointees will contribute as appropriate to curriculum development and renewal in relation to Philosophy and to Artificial Intelligence, in collaboration with other disciplines.

We particularly encourage applications from those with an interest in innovative teaching, learning and assessment; those with experience of supporting a wide variety of students; and those belonging to groups underrepresented in UK higher education. We are open to appointing on a reduced fraction/job-share basis subject to our business needs.
