## The role

The New College of Humanities at Northeastern wishes to appoint a full-time Lecturer (Teaching) in Criminology for a period of 5.5 months. We wish to appoint a specialist who is able to deliver teaching for two courses in Criminology (Criminology and Crime, Media and Politics) to undergraduate exchange students. Preference may be given to candidates with active interests in the relationship of criminology to one or more of the following areas: software and/or technology; employment contexts; diversity and inclusion.

Core duties will include adapting existing course syllabi from a US-centric focus to suit the study of Criminology in the UK, as well as the preparation and delivery of classes and formative and summative assessment of students. The person appointed to the position will furthermore be required to offer weekly office hours (delivered remotely via Zoom) for both courses and prepare and upload relevant teaching materials to a virtual learning environment. Classes are taught in bi-weekly seminars and add up to 156 contact hours over the course of the entire appointment period. Classes will need to be taught on-site, at a central London location.

We particularly encourage applications from those with an interest in innovative teaching, learning and assessment; those with experience of supporting a wide variety of students; and those belonging to groups underrepresented in UK higher education. We are open to appointing on a reduced fraction/job-share basis subject to our business needs.
