## The role

The New College of Humanities at Northeastern wishes to appoint a part-time Lecturer (Teaching) in Microeconomics.

We wish to appoint a specialist in Microeconomics who is able to teach Industrial Organisation at third-year undergraduate level. The appointee will be flexible, able, and willing to be wide-ranging in their teaching and in their professional development.

Preference may be given to candidates with active interests in the relationship of Microeconomics to one or more of the following areas: software and/or technology; employment contexts; diversity and inclusion.

Each course of the two involves approximately 21 teaching hours over 6 weeks, with a fee of £3,600 for each course. Candidates are invited to specify whether they are applying to teach both courses, or one course (and to please specify which). Core duties will include teaching, marking, office hours, and support of students. Previous course materials are available. The fee for each course includes time for innovation (the design and preparation of teaching and assessment).

We particularly encourage applications from those with an interest in innovative teaching, learning and assessment; those with experience of supporting a wide variety of students; and those belonging to groups underrepresented in UK higher education. We are open to appointing on a reduced fraction/job-share basis subject to our business needs.
