The role

The New College of Humanities at Northeastern wishes to appoint an Assistant Professor in International Business. The appointee will teach courses in Business to undergraduate students, including the setting of assessments, marking, and relevant quality assurance tasks, while also participating in Service tasks for the Faculty or the wider College.

We wish to appoint a specialist in any area of Business. Preference may be given to candidates with active interests in the relationship of Business to one or more of the following areas: software and/or technology; employment contexts; diversity and inclusion.

Core duties will include: Teaching the assigned course(s) in Business, which may include the creation

or improvement of course materials, and working on a team to make the course interesting and engaging. The appointed person will also be expected to mark assessments, hold regular office hours (online), and contribute to following the College's procedures around assessments and marking. There is also an expectation of service to the Faculty or the wider College.

We particularly encourage applications from those with an interest in innovative teaching, learning and assessment; those with experience of supporting a wide variety of students; and those belonging to groups underrepresented in UK higher education. We are open to appointing on a reduced fraction/job-share basis subject to our business needs.

Department

The wider multidisciplinary Faculty of Economics currently comprises subject teams in Economics, general Business, Marketing, Accounting, Mathematics, and Project Management. In addition, many programmes are collaboratively designed both between these specialisms and in collaboration with other subjects in the College, as well as with academic teams on other campuses of Northeastern University.
