The role

The New College of Humanities at Northeastern wishes to appoint a Lecturer in Accounting. The appointee will teach an introductory course called Financial Accounting & Reporting to Northeastern exchange students, including some preparation of teaching material together with a team of lecturers; the design and marking of assignments. Teaching of the course will commence in January 2023.

We wish to appoint a specialist in Financial Accounting. Preference may be given to candidates with active interests in the relationship of accounting to one or more of the following areas: software and/or technology; employment contexts; diversity and inclusion.

Core duties will include: Teaching US exchange students in Financial Accounting & Reporting,

including some provision of course materials and working on a team to make the course accessible and engaging. The appointed person will also be expected to mark assessments, hold regular office hours (online), and contribute to following the College's procedures around assessments and marking.

We particularly encourage applications from those with an interest in innovative teaching, learning and assessment; those with experience of supporting a wide variety of students; and those belonging to groups underrepresented in UK higher education. We are open to appointing on a reduced fraction/job-share basis subject to our business needs.

Department

The multi-disciplinary Faculty of Economics currently comprises subject teams in Economics, general Business, Marketing, Accounting, Mathematics, and Project Management. In addition, many programmes are collaboratively designed both between these specialisms and in collaboration with other subjects in the College, as well as with academic teams on other campuses of Northeastern University.
