The role

The New College of Humanities at Northeastern wishes to appoint a Lecturer in Statistics. The appointee will teach a course in introductory Statistics and act as Course Leader, including setting assessments, marking, and relevant quality assurance tasks. Teaching will commence in January 2023.

We wish to appoint a specialist in Statistics. Preference may be given to candidates with active interests in the relationship of Statistics to one or more of the following areas: software and/or technology; employment contexts; diversity and inclusion.

Core duties will include: Teaching US exchange students in Statistics, including some provision of course materials and making the course accessible and engaging. The appointed person will also be expected to mark assessments, hold regular office hours (online), and contribute to following the College's procedures around assessments and marking.

We particularly encourage applications from those with an interest in innovative teaching, learning and assessment; those with experience of supporting a wide variety of students; and those belonging to groups underrepresented in UK higher education. We are open to appointing on a reduced fraction/job-share basis subject to our business needs.

Department

The multi-disciplinary Faculty of Economics currently comprises subject teams in Economics, general Business, Marketing, Accounting, Mathematics/Statistics, and Project Management. In addition, many programmes are collaboratively designed both between these specialisms and in collaboration with other subjects in the College, as well as with academic teams on other campuses of Northeastern University.
